

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.jekyllnhydennp.com/>, and Jekyll Hyde LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Jekyll Hyde LLC include <https://www.jekyllnhydennp.com/> and Jekyll and Hyde Nutrition and Performance. The Jekyll and Hyde Nutrition and Performance website is a membership site. By using the Jekyll and Hyde Nutrition and Performance website, you consent to the data practices described in this statement.

Collection of your Personal Information
